
02. The orders in respect of officers at Sl. No. 1 will be effective from 01.10.2011.

02.01. The orders in respect of officers who were transferred out during AGT 2010 / repatriation from deputation will be effective from the date of completion of one year tenure

02.02. The orders in respect of officers who were transferred out on promotion will be effective from the date of completion of two years tenure.

All other officers should be relieved on or before 30.06.2011.

03. The Officers nominated to Chennai-III Outside are meant for posting to outer areas of Chennai-III Commissionerate (To places considered as not part of Chennai city).
04. Orders have been issued after taking into due consideration of all the representations seeking transfer or retention submitted to this office. This order disposes of all the requests for retention/transfer/change of Commissionerate.
05. All the officers who have been transferred at their own requests will not be entitled to transfer benefits in terms of Supplementary Rule 114.
06. Any representation by the above officers would be entertained only if they are made after joining at the new place of posting.
07. This issues with the approval of the Competent Authority, Cadre Control, Tamil Nadu and Puducherry.
