Subject: Harassment to the members.

Sir,

Kindly refer to the communication No. Lr. 26/11 Dt. 03.08.11 of the Chennai Unit of the Association.

The matter of harassment to the office bearers as well as members of the Association in the field formations is regularly being brought to the knowledge of the Board authorities. The Board authorities are regularly being kind enough to ask the specific instances and give directions to the field formations accordingly. A new instance of not only of acute harassment but also of playing with the career of one officer is being brought to your kind knowledge with the the request to intervene into the matter and save the said officer from further harassment and protect his career prospects. Sh. S. K. Balasubramaniam, one of our Superintendents belonging to Chennai Zone, was forcefully brought back to Chennai Central Excise from Chennai CESTAT in mid-term only after a period of two and half years without completion of his deputation period of 5 years. He was also further transferred out of Chennai despite of the fact that he went on deputation to CESTAT after a stint in Puducherry. He was called back forcefully despite of the strong recommendations of the Joint CDR not to repatriate him from CESTAT. The copies of the above referred communication of the Chennai Unit of the Association as well as of the letter of Joint CDR are enclosed herewith explaining whole episode of the acute harassment and depriving the officer from better career prospects.

In view of the above, your goodself is requested to kindly give justice to the said officer.
