In pursuance of our earlier letter cited against reference[07/11 dated 28/02/11] wherein we had made a mention of the letter issued by CBEC F. No A – 23011/29/2010 –Ad IIA dated 25th February 2011 which categorically lays down that all officers who have been given 2nd ACP under the old ACP Scheme of 1999 between 01/01/2006 and 31/08/2008 [in addition to emphasizing that all officers awarded 2nd ACP before 01/01/2006 are to be given 6600 GP carrying a pay scale of Rs. 15,600-39,100/- in PB 3 on 3rd Financial Up Gradation immediately on completion of 30 years] are to be placed in PB3 with 5400 GP and the zero effect on the grant of Non Functional scale to such category of officers. Hence it is requested that all officers awarded 2nd ACP between 01/01/2006 and 31/08/2008 be placed in PB 3 with GP of 5400[15,600-39,100/- Gr. A entry scale] immediately, extending attendant benefits that go with the fixation of such a scale by issuing necessary instructions to Admn. Officers under your control. This request is without prejudice to our claim for interest.
