

Please refer our letter 27/10 dated 11/08/10[with attendant earlier references] on the subject, addressed jointly to Chief Commissioner of Central Excise, Chennai Zone and to all Commissioners in Chennai Zone. Please find enclosed a copy of letter F. No A – 23011/29/2010 –Ad IIA dated 25th February 2011 which was in response to the petition[s] filed in Hon'ble CAT, Chennai. The contents are self explanatory on the substantive issues raised by us in our earlier letters on the issue of GP 6600[3rd MACP], placement of all 2nd ACP officers in PB3 with 5400 GP and the zero effect on the grant of Non Functional scale to such category of officers. It is also mentioned that during the hearing before Hon'ble CAT on 28/02/2011, the counsel for the PAO, made a submission, conceding all the above and to clear all bills sent to them within a week of receipt. Our stand is vindicated and it is requested that all bills be sent immediately to PAO, Chennai. This request is without prejudice to our claim for interest.
