

Dear friends,

1. The decisions of Board on counting of service and loan basis postings is attached herewith as image (7).tif. One is based on DOPT clarification and other on the clarification of Board itself. DOPT clarification is totally discriminatory and Board clarification also has no statutory force. It is surprising that Board is not ready to implement its own letter on loan basis postings. They only want to treat us as non-living articles. It seems that we'll have to approach the legal court on these two issues too.

2. Some more correspondence made with the administration is attached herewith as another attachment.

3. The advocate is already preparing the case for parity with Examiners to be filed in the CAT very soon having Inspectors/Inspectors Association as co-applicants with Superintendents/Superintendents Association.

4. The advocate is also preparing the case for time scale in PB3 to be filed in the CAT by the Association (All India body or Delhi Unit as per tactics).

5. Dear friends, it has already been proved that we are unable to show our physical strength due to one reason or another. But there should be no problem in the collection of funds. As we all know very well, we require huge funds for legal battle on various issues. We'll have to file one more case challenging the ratio formula in the Hon'ble SC requiring more funds. The Board has itself observed in its minutes that any change of ratio would not solve the problem. They have also observed that the vacancies coming as a result of the cadre restructuring would be insufficient for the purpose. They have also said that problem would be solved only after giving equal opportunities for promotions to all. We all know that we can't win any case without engaging senior advocates who charge rupees in lacs per hearing. So, it is requested that all may kindly start the work of collection of funds to have a large buffer stock. We at least shouldn't be defeated due to the want of funds. We have to fight many things including promotion case, pay scale, arrears, implementation of para 7.15.24, time scale, para 8.1, offsetting of MACP benefit with time scale, implementation of MACPS w.e.f. 01.01.06, additional increment for those having date of increment between Jan'06 and July'06, time scale for everyone irrespective of date of joining, 6600/- and 7600/- on IInd and IIIrd MACP upgradation respectively for everyone irrespective of date of joining etc. There may be many more issues in the interest of the cadre. Therefore, we have not to hesitate even a little to collect the funds.
