Subject: Promotions against the existing vacancies of Asstt. Commissioner.

Sir,

Kindly refer to the various previous communications of the Association on the above issue as well as the meetings held with the administration.

Your kind attention is also invited to the minutes issued vide F. No. A/11012/01/2011-Ad IV Dt. 26.07.11 of CBEC and the decision taken in r/o point No. 12 submitted by the Association.

It is requested that the letter to the respective Chief Commissioners may kindly be sent at an early date to call requisite informations in r/o the promotions to be made against the existing vacancies as a good number of our officers are retiring every month. It is further submitted that it was decided during the presentation made on the cadre restructuring on 18.01.11 that no direct recruitment would be made for more than 1 years. Now, the disparities in the promotions have also been established by the verdict given by the Hon'ble Supreme Court itself on 03.08.11 and the Hon'ble court has given directions to remove these disparities means more number of vacancies would be given to Central Excise after reviewing all the ad hoc promotions on the basis of new Recruitment Rules. Keeping in view all the developments and the decision taken in the presentation of 18.01.11 not to make any direct recruitment for more than 1 years, it is also requested that all the vacancies against retirements for coming at least 2 years may also be calculated and all of those may be given to the Central Excise personnel including all of the existing vacancies and the DPC may be held accordingly.
