### **Subject: Shifting of CC, Customs Preventive office from Chennai to Trichy.**

Sir,

It is submitted with due regards that the office of the Chief Commissioner of Customs Preventive is being shifted from Chennai to Trichy in the mid-term. It is true that the Customs Preventive Commissionerate Hqrs of the Zone is at Trichy. But at the time of formation, it was located at Chennai perhaps for the convenience of the higher level officers and administration. The said office has been functioning from Chennai till date. Now, all of a sudden the office is being shifted to Trichy.

It is further submitted that the move during the middle of the year shall place the staff on great inconvenience due to the following reasons-

1. The existing building, in which both the Excise and Customs Commissionerates are being housed, is already congested and there is no space to establish the office of the Chief Commissioner of Customs Preventive.
2. No new building at Trichy can be located on such a short notice for the said office.
3. The officers should not be shifted during the middle of the financial year as they have to face domestic problems such as accommodation, schooling of wards etc.
4. The shifting of the office at this juncture of time will cause immense hardship to the staff.

In view of the above, it is requested that the shifting of the said office may kindly be done only at the time of the next educational year to give justice to the staff; otherwise it will necessitate maintaining the double establishment. If it is postponed till the end of the academic year, the staff will be able to make necessary arrangements.
