Sub : Self Appraisal System by Range Officers – Regarding.

This Association brings to your notice a letter[C. No IV/16/15/2009 Cx. Pol Vol II P.II dated 24/11/11] issued by the Assistant Commissioner, Central Excise, Hosur I Division.

The reservations have already been made known vide letters 37/11, 38/11 & 41/11 of this unit. The request to do away with the exercise is made again in the context of the letter cited supra.

The letter of ACCE, Hosur I Division has thrown up the following surprises.

- 1.That the charter of functions of the Association is decided by the Department rather than the Members themselves and that the Administrators decide what issues are to be taken up by the cadre.
- 2.That there is a scientific analysis of the functions performed/achieved by the Range Officers in the context of RFD and that the RO's would have to perform very well as to make the RFD coming out in full glory and earning a section of the Department incentives.
- 3.That through such scientific analyses the rules governing service conditions/promotions will be sidelined and the promotions fast tracked to meritorious candidates ignoring the various social legislations.
- 4.That based on such scientific evaluation, the postings are to ordered[In future][IN AN IMPLICIT WAY]

It is requested that the cadre may be surprised again by a scientific evaluation conducted on the Administrative side, and the representations on various petitions, relating to pay anomaly/ promotions be addressed as to provide relief to the stagnating officers, which in the long run will automatically enhance the efficiency of all officers.
