All the Commissioners are required to take note of the principle of periodical rotation of officers from sensitive to non-sensitive charges after a period of 2 years strictly in accordance with instructions contained in Circular No. 01/2000 dated 10th May, 2000 of Directorate General of Vigilance. While doing so, history of posting and clearance from vigilance angle in respect of officers should also be taken into account. The internal rotation order may be issued by the Commissionerates by **25.06.2014** and a certificate to this effect is required to be sent to this office by **30.06.2014**.
