Subject: Transfer/posting issue in Chennai Zone.

Sir,

Kindly refer to-

- i) the point No. 4 of the Ref. No. 153/10 Dt. 08.12.10 of the Association and the subsequent submissions made to your goodself in the meeting held on 16.12.10.
- ii) Assn Lr. 51/10 Dt. 10.12.10 of Chennai Unit of the Association addressed to the Member (P&V) and copy endorsed to your goodself.

It is further submitted with due regards that the transfer/posting policy issued vide C. No. II/3/51/2008 is not being followed in Chennai Zone. Very recently, 11 officers have been retained at Chennai on promotion violating the para 4 of the policy. This retention also violated the para 6 of the policy by not enabling the transfer back of the officers completing the stipulated tenure gone out in the earlier years on promotion. Moreover, an old aged officer named Sh. N. Raman has been transferred outside retiring within next 25 months. The latest transfer orders have resulted in the unjustified retentions in addition to those five who have been sent to LTU. The LTU posting has been managed by bringing 4 officers back to the City Commissionerates thus blocking the vacancies.

In view of the above, it is requested that the Transfer order No. 91/10 dt. 12.10.10 of Chennai Zone may kindly be rectified accordingly to follow the policy in its true spirit. Your **telephonic intervention** into the matter is also very much requested keeping in view the agitational action including the hunger strike adopted by the staff Associations in the recent past in Chennai. Such actions always tarnish the image of the organisation.
